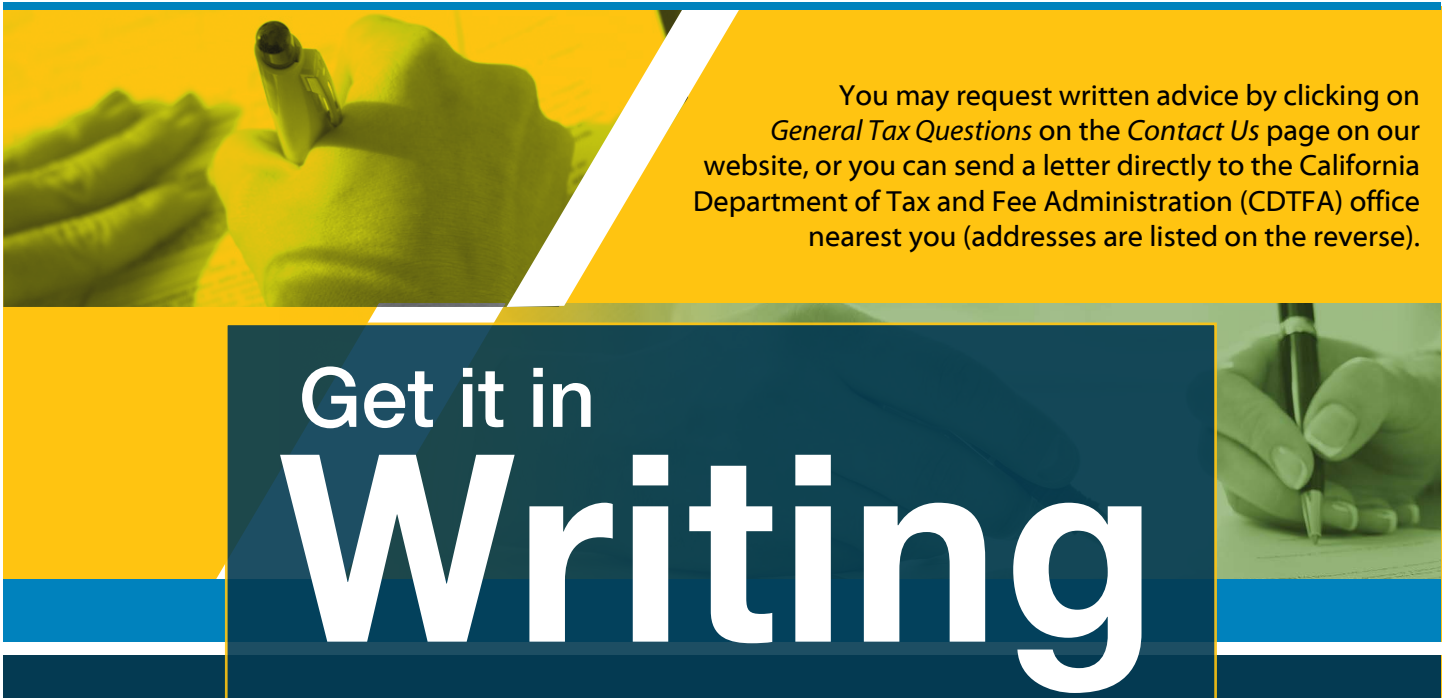




You may request written advice by clicking on *General Tax Questions* on the *Contact Us* page on our website, or you can send a letter directly to the California Department of Tax and Fee Administration (CDTFA) office nearest you (addresses are listed on the reverse).

Get it in Writing

The law can be complex, and **you are encouraged to put your questions in writing**. Not only will that give us more information on which to base our advice to you, it may protect you from owing tax, interest, or penalties if we should give you erroneous information. **Such protection is not provided for advice given to you verbally, in person, or on the telephone.**

You can obtain relief from tax and any penalty or interest charges if you failed to report tax on a transaction because you relied on erroneous written advice from CDTFA (Revenue and Taxation Code [section 6596](#)). There are similar provisions for relief from a special tax or fee and any penalty or interest charges if you failed to report a special tax or fee on a transaction because you relied on erroneous written advice from CDTFA (California Code of Regulations, Title 18, [section 4902](#)).

For this relief to apply, the following conditions must be met:

- You must have written to us for tax advice, and your request must have described the specific facts and circumstances of the activity or transaction (if someone writes on your behalf, you must be identified as the taxpayer to whom the advice applies); and
- We must have responded in writing and stated whether the described activity or transaction was subject to tax or stated the conditions under which tax would apply.

If you have received written advice from us and request relief, it cannot be granted if, following our letter of advice:

- We wrote to you and modified or rescinded our earlier advice, and your tax or fee liability is for a transaction that occurred after such notification; or
- There has been a change in the law or a final decision of a court, which renders our earlier written advice no longer valid.

In addition to written advice, we offer other resources to help you understand the law:

- You can call or visit the nearest CDTFA office and talk to a tax representative.
- You can request a copy of a regulation or a publication.
- You can subscribe to our law guide service.
